

Town of Newbold Outdoor Recreation Committee Meeting Minutes
Meeting of Monday, February 8, 2016 at 9:00 a.m.
Newbold Town Hall, 4608 Apperson Drive and Hwy 47, Rhinelander, WI 54501.

Those present: Pete Cody, Jackie Cody, Ed Hammer and Kim Gauthier.

Public present: none.

1. Mr. Cody, Chairman called the meeting to order at 9:00 a.m. Pete Cody verified the meeting notice was properly posted.
2. Approve Newbold Outdoor Recreation Committee minutes. *A motion was made by Jackie Cody and seconded by Ed Hammer to approve the January 11, 2016 meeting minutes as corrected. That motion carried on a vote of four ayes.*
3. Fundraising, grant, budget, disc golf course and face book page.
 - a. Mr. Cody reported on the fundraising contacts that have been made thus far by the committee. There appears to be great interest in the project and several bench donations have come in. Fundraising efforts will continue.
 - b. Mr. Cody presented a draft budget of the project. There was committee discussion on the budget categories and projected amounts. This will be discussed further at the next meeting.
 - c. A Facebook page has been created: Friends of the Newbold Recreation Outdoor Area. Jackie Cody will be the administrator of the page and updates about the recreation area will be posted.
4. Disc golf course discussion.
 - a. Mr. Cody reported that brush piles will be burned in the coming weeks.
 - b. Discussion on a theme for the course. Kim Gauthier presented seven different possible course names and suggestions for a background picture. The committee particularly liked two of the names and will discuss further at the next meeting.
 - c. Winter use has been limited due to lack of snow.
 - d. Mr. Cody recommended the committee obtain travel approval from the Town Board for the designers to visit the site this Spring. This will be discussed further in March.
 - e. A thank you letter was sent to Wayne Wagler for the significant amount of tree removal he did on the course. The committee expressed great appreciation in having Mr. Wagler part of the project.
5. Administrative matters for review and discussion by the Outdoor Recreation Committee including future meeting schedules, agendas and project updates.
 - a. The next NORC meeting is set for Monday, March 14th at 9:00 a.m.
 - b. Mrs. Cody agreed to also look into other community grant opportunities before the next meeting.
6. Public comment and communication pursuant to Wisconsin Statutes whereby the Town Outdoor Recreation Committee may receive input on matters raised by the public. None.
7. Adjournment. A motion was made by Pete Cody and seconded by Ed Hammer to adjourn the meeting at 10:55 a.m. There was no objection.
