

Minutes of the Special Town Board Meeting held on Thursday, September 2, 2021

The Town of Newbold Town Board, met on Thursday, September 2, 2021 at 6:00 p.m., for a Special Town Board meeting at the Town of Newbold Town Hall, 4608 Apperson Drive, Rhinelander, Wisconsin, 54501, Oneida County, Wisconsin.

The following were in attendance: Chairman, Dave Kroll, Supervisors, Jim Staskiewicz, Mike Suefloh and Mike McKenzie along with Clerk, Kim Gauthier and Public Works Director, Mark Fetzer.

Chairman Kroll called the meeting to order at 6:00 p.m., and verified the agenda was properly noticed to the public. It was noted the agenda was amended to specifically discuss hiring a part-time road crew staff and hiring a town hall cleaning service/person.

Discussion and possible action on the following:

The Town of Newbold Town Board may convene into Closed Session pursuant to Section 19.85 (1) (c), considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility.

Motion made by Mr. Staskiewicz and Mr. Suefloh to go into closed session. Roll call vote: McKenzie, aye; Staskiewicz, aye; Suefloh, aye; Kroll, aye. Motion carried.

The Town of Newbold Town Board will reconvene into open session to make decisions on closed session discussions above.

Motion made by Mr. Suefloh and Mr. Staskiewicz to return to open session at 6:30 p.m. Roll call vote: McKenzie, aye; Staskiewicz, aye; Suefloh, aye; Kroll, aye.

Motion by Mr. McKenzie and Mr. Staskiewicz to approve hiring Thomas Pierce (for the part-time road crew position). That motion carried on a voice vote of all aye.

Motion by Mr. Staskiewicz and Mr. Suefloh to approve hiring Susie Wachtl (for cleaning the town hall). That motion carried on a voice vote of all aye.

Chairman Kroll noted the closed session sign was retrieved and no members of the public were present.

Administrative review and action, if necessary, concerning general government, public safety, recycling, sanitation, culture, education, job assignments, project updates, transportation, budget items, fund transfers, and future agenda items.

Mr. Staskiewicz requested discussion on the Tom Doyle boat launch at the September 9th meeting. Chairman Kroll requests appointment of a plan commission member at the next meeting.

Public Comment and Communication Period per Wisconsin Statutes whereby the Town Board may receive input on any matter raised by the public. *None*

The meeting was adjourned at 6:33 p.m., on a motion by Mr. Staskiewicz and Mr. McKenzie. Motion carried with no objection.
